



What it means to support the Elmore Medical Center Foundation

The Elmore Medical Center Foundation owes its existence to a handful of dedicated individuals who made a commitment to the community to ensure that Elmore Medical Center continue in its role to provide quality healthcare, close to home.

Each year the Elmore Medical Center Foundation selects an item from the Elmore Medical Center capital needs lists and raises funds to help support the purchase of that item. In past years this Annual Campaign has provided funding for the Long Term Care Unit Van, paid for nearly half of the cost to install a new helipad at the hospital, partially funded the mobil digital C-Arm X-ray machine, purchased an infant warmer, portable bone density scanner, defibrillator and most recently a ventilator.

To provide for ongoing, long-term financial support to Elmore Medical Center and healthcare needs in our communities the Endowment Fund was established in 2005. All principal investments into the fund will remain in perpetuity and the interest and dividends earned by the fund will be used to provide for equipment, staff training, physician education, technology upgrades and facility improvements.

In 2007 the Foundation established a scholarship fund to help Elmore Medical Center staff members continue their education to become licensed nurses.

Undesignated donations will be used for the greatest need as determined by the Foundation Board of Directors.
